## Deadline to Enter: June 30, 2017

- Cooperative members, directors, employees and their family members—18 years and older—are eligible.
- Photos may be any appropriate subject or scene, but must be taken in the Jo-Carroll Energy service area.
- A complete entry form must accompany each photo.
- The entrant must have the rights to the photo. A photo release form must accompany any photos that include people.\*
- Printed Photos: Must be quality prints; photos printed on home printers or copy machines may not be high enough quality for print publications. Do not write on the photo. Original photos will not be returned.
- Digital Photos: Files should be at least 300 dpi and 12" x 9" or larger. Do not send scanned photos.
- Photos will be judged on an anonymous basis by a panel to include photographers and Jo-Carroll Energy staff.
- Photos should have a horizontal orientation.  
\*Provide signed photo release forms if there are recognizable people in your photo. a parent or guardian must provide written authorization for any photographs of minors. Download the release form from our website or contact our office at 800-858-5522.
